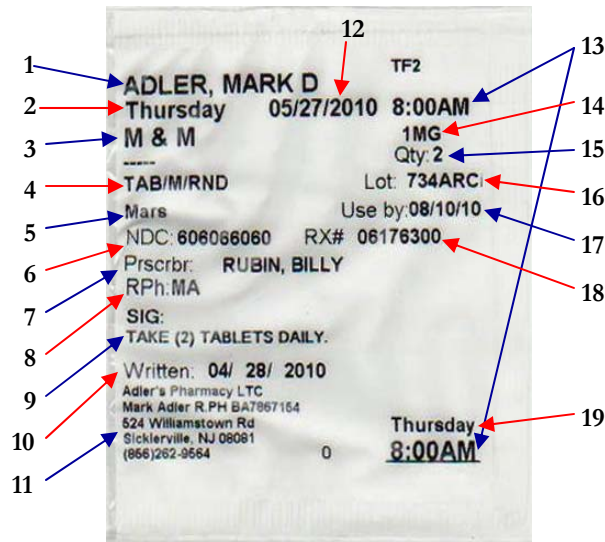

AccuFlo eMAR:

QS/1 WebConnect™:



The user friendly browser based software allows authorized staff to securely access, search, edit and print patient and medication information quickly and easily. This access also enables staff to submit PRN refills and check the current number of refills on a particular prescription. WebConnect is also accessible via a QS/1 iPad application.

oneDOSE:

oneDOSE delivers a single dose of medication with secure access, allowing nurses to retrieve first doses and STAT dispenses.

oneDOSE is only accessible to authorized users. 450 unique doses in separate, secure bins are readily available and easily refillable. Real-time reports on dispensing, inventory, restocking and aging are easily viewed.
